The purpose of this notice is to provide investors with updated valuation information in respect of the Fund as at 30 September 2018.

The value of the Fund

The directors of the Guernsey Cells have now published the finalised Net Asset Values ("NAVs") of the Guernsey Cells as at 30 September 2018. Based on that information, we have calculated that, as at 30 September 2018, the NAV of the Fund was £880,266.

We have set out in the table below the price of each class of share in the Fund as at 30 September 2018. For reference, the table also includes the share price as at 30 June 2018 and the pence per share rate of the twelfth Capital Distribution made on 8 May 2018.
