**LF Arch Cru Global Growth Fund (a sub-fund of the LF Arch cru Diversified Funds, an Investment Company with Variable Capital) (the "Fund")**

The purpose of this notice is to provide investors with updated valuation information in respect of the Fund as at 31 March 2025.

**The value of the Fund**

The directors of the Guernsey Cells have now published the finalised Net Asset Values ("NAVs") of the Guernsey Cells as at 31 March 2025. Based on that information, we have calculated that, as at 31 March 2025, the NAV of the Fund was £55,797.

We have set out in the table below the price of each class of share in the Fund as at 31 March 2025 and the percentage change in price since 30 September 2024.
