The purpose of this notice is to provide investors with updated valuation information in respect of the Fund as at 30 September 2017.

The value of the Fund

The directors of the Guernsey Cells have now published the finalised Net Asset Values ("NAVs") of the Guernsey Cells as at 30 September 2017. Based on that information, we have calculated that, as at 30 September 2017, the NAV of the Fund was £23,397,456.

We have set out in the table below the price of each class of share in the Fund as at 30 September 2017. For reference, the table also includes the share price as at 30 June 2017 and the pence per share rate of the eleventh Capital Distribution made on 24 May 2017.
